#### Dear Friends,

St. Bernard Academy continues to live in a culture of giving that goes back to the early days of the Sisters of Mercy as they built and moved into their dream facility on Hillsboro Turnpike in 1905. Mother Xavier was up to the task of carrying out their mission as "the brave little figure went in and out of homes, banks and stores." Inside of one year, she had raised the \$40,000 needed to build the facility that would become the center of Mercy culture and life in Nashville. "Four stories with a sub-basement... heated by steam, and supplied with gas and electric lights, and all modern conveniences." This, of course, was the St. Bernard Convent!

Over 100 years later, we are so grateful for the kind and generous financial support witnessed in the following pages. This generosity is critical to the daily work our students, faculty, and staff do inside the building. It is also relevant to our community as we continue our work to make St. Bernard Academy affordable for a diverse group of Nashville families. Charging tuition yields the lion's share of our budgeted revenue, but the gifts-in-kind, support from foundations, company matching gifts, and tax-deductible gifts to our Annual Fund help bridge the gap.

We understand, too, that it is not just financial contributions that provide the foundation for our thriving school community. Parents, grandparents, alumni, and past parents all give their time and talents throughout the year. We invite you to get more involved with our SBA family. Please visit campus, share your skills and expertise with our students and faculty, or attend one of our community events. Dear St. Bernard Community,

With a record number of new student applications, interest in St. Bernard Academy is at the highest level in recent memory. In August 2019, we expect to welcome over 360 students, an increase of more than ten percent over just four years ago. The growth and interest is due in no small part to the great work by our faculty and staff as well as your work in communicating the strengths of our school to prospective parents.

As we have done in the past, in fall 2018, we embarked on a fiveyear strategic plan to make sure that the school's long-term goals

aligned with those of our constituency groups. Informed by the results of the 2017-2018 fiscal year, we began with a comprehensive survey that was followed by a retreat focusing on the priorities identified in the survey. Thank you to all who took time out of your busy schedules to attend the retreat and complete the survey.

Notwithstanding the strong interest and growth, like all schools — and in fact, many businesses in Nashville — our operating costs continue to rise. Many of you may not know that the cost of educating a student for the 2017-2018 school year was \$12,984 while student tuition was \$11,900. To make up for this shortfall, as in prior years, we relied on the Annual Fund. Thank you to all who made charitable contributions to the Annual Fund as well as secured matching gifts from your company. We also thank all the volunteers who participated in the HSA Auction and other fundraising projects throughout the year.

After serving on the Board for five years, there is no doubt in my mind that the school is in an excellent position. In addition to the strong demand, students continue to excel in academic competitions, and the school was recognized by the U.S. Department of Education as a 2017 National Blue Ribbon School. Perhaps, most importantly, all stakeholders seem to be genuinely interested in working together to make the school a welcoming and thriving educational environment in the spirit and tradition of the Sisters of Mercy. I truly appreciate your financial support and involvement at the school.


